7.1 Precautions for safe handling

Protective measures

Ensure adequate ventilation.

No special instructions at ambient temperature. Avoid the release of the product - slippery surface. Vapors can arise at processing temperature: development of propylen, ethylene, hydrocarbons with low molecular weight and their oxidation products, solvents, traces of aldehyde (formaldehyde and acroleyn), traces of acids (formic and acetic acid). During the process you must wear masks and there must be an aspiration system.
